Temporary Food Establishment Commissary Application

This application must be completed and submitted to Moore County Environmental Health to provide information about all food preparation and sales to the public at any public event or exhibition within Anson County. This Temporary Food Establishment Commissary application must be submitted with the corresponding Food Vendor Application **no later than 15 days prior to the event**. APPLICATIONS SUBMITTED LESS THAT FIFTEEN (15) DAYS PRIOR TO THE EVENT WILL BE CONSIDERED SUBJECT TO AVAILABILITY OF ENVIRONMENTAL HEALTH STAFF. APPLICATIONS ACCEPTED AFTER THE FIFTEEN DAYS WILL REQUIRE AN ADDITIONAL LATE FEE OF \$75. **FEES ARE NON-REFUNDABLE**

- No food preparation shall occur prior to receiving a permit from Anson County Environmental Health.
- No food preparation shall occur more than 7 days prior to the event.
