INSPECTION SCHEDULE

- Once Every Year.....** Hazardous, Institutional, High Rise, Assembly and Residential except one and two family dwelling and only interior common areas of dwelling units of multi-family occupancies.
- Once Every Two Years.....** Industrial and Educational (except public schools).
- Once Every Three Years.....** Business, Mercantile, Storage, Churches and Synagogues, and miscellaneous Group U occupancies
